Invitation for Tenders

5. Interested eligible Tenders may obtain further information from and inspect the Tendering Documents at the office of the *Secretary, AICC Tender Board*, Box 3081 Arusha, from 8.30 am to 4.30pm on Mondays to Fridays inclusive except on public holidays.

A complete set of Tendering Document(s) in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **Tshs 100,000.00**. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to **Managing Director, AICC**

7. All tenders must be accompanied by a Tender Securing Declaration in the format provided in the Tendering Documents.

All tenders in one original plus *two copies* properly filled in, and enclosed in plain envelopes marked Tender No. PA075/HQ/2018/19/G/35 *“Supply and Installation of CCTV Camera”* indicating specific lot must be delivered to the address shown at the bottom of this advert at or before **1430hrs, Friday, 28/6/2019**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers’ representatives who choose to attend in the opening at the AICC Complex, Manyara room, 3rd, Floor Ngorongoro wing.
